Fee waiver and significant investment

MAAM RE Ltd ACN 135 855 186 (AFSL 335783), in its capacity as responsible entity (**Responsible Entity**) of the MA Secured Real Estate Income Fund ARSN 648 810 904 (**Fund**), provides the following update as part of its continuous disclosure obligations.

1. Management fee waiver: June 2021

MA Investment Management Pty Ltd (**Manager**) is entitled to receive a management fee out of the assets of the Fund equal to 1.03% of the Fund's NAV per annum, calculated and payable monthly in arrears as set out in the Fund's product disclosure statement (**PDS**). The Manager will waive this entitlement for the month of June 2021. The Manager has not waived this entitlement for May 2021.

2. Significant investment

A related party of the Responsible Entity (MA Investor) has applied to invest \$5 million in the Fund. The units will be issued to the MA Investor on 1 July 2021 at the same unit price, and on the same terms (being those terms disclosed in the most recent PDS, dated 3 May 2021) as will be offered to all investors who have applied for, and are issued units in the Fund on that date. The MA Investor may progressively submit withdrawal requests in accordance with the terms and conditions outlined in the PDS (Withdrawal Requests). The Responsible Entity will accept or reject these Withdrawal Requests in accordance with the PDS.
