## MA Secured Real Estate Income Fund

This document should be read in conjunction with the current Secured Real Estate Income Fund (Fund) Product Disclosure Statement dated 1 October 2021 (**PDS**).

The estimated ongoing annual fees and costs shown in Section 8 of the current PDS include management fees and costs, estimated performance fees and estimated transaction costs (based on the previous financial year ended 30 June 2021) as at the date of the PDS. In accordance with *ASIC Corporations (Updated Product Disclosure Statements) Instrument 2016/1055*, the table set out below updates and replaces the table under Section 8.1 Fees and costs summary of the PDS and the provides updated estimated ongoing annual fees and costs based on updated estimated management fees and costs, updated estimated performance fees and updated estimated transaction costs reflecting the latest completed financial year ended 30 June 2022.

# Example of annual fees and costs for the Fund

This table gives an example of how the ongoing annual fees and costs for the MA Secured Real Estate Income Fund can affect your investment over a 1-year period. You should use this table to compare this product with other products offered by managed investment schemes.

We have assumed that the \$5,000 contribution is made at the end of the year and that the value of the investment is a constant. This example is therefore calculated using the \$50,000 balance only. Please note that this is just an example. In practice, actual investment balances will vary daily and the actual fees and costs charged are based on the value of the Fund, which also fluctuates daily.
